Stanley Fish is one of this country's leading public intellectuals and a world-renowned literary theorist and legal scholar. Currently professor of humanities and law at Florida International University, he began his academic career in the English Department at the University of California, then became Kenan Professor of English and Humanities at Johns Hopkins University, where taught from 1974 to 1985, before becoming Arts and Sciences Professor of English and Professor of Law at Duke. He was dean of the College of Liberal Arts and Sciences at the University of Illinois from 1999 to 2004. Professor Fish is an extraordinarily prolific author, having written over 200 scholarly books and articles. His books include *Surprised by Sin: The Reader in Paradise Lost*; *There's No Such Thing as Free Speech, and It's a Good Thing, Too*; *Professional Correctness: Literary Studies and Political Change*; and *How Milton Works*. His newest book, a study of 1960s TV drama entitled *The Fugitive in Flight*, will appear in November 2010.
