

## Benjamin N. Cardozo School of Law Certificate in Dispute Resolution

Students who wish to obtain a Certificate in Dispute Resolution must complete the following:

A) Obtain **fifteen (15) credits** in courses that satisfy four of the five dispute resolution **Competency Requirements**:

- 1) Negotiation
- 2) Mediation
- 3) Arbitration
- 4) Dispute Resolution Processes
- 5) Interviewing and Counseling

Up to three (3) of the fifteen (15) credits may be obtained from approved litigation courses.

- B) Meet the **Experiential Requirement** of sixty (60) hours of work in a dispute resolution related clinic or externship. Dispute resolution clinics include the ADR Field Clinic, the Divorce Mediation Clinic, the Mediation Clinic, and the Securities Arbitration Clinic.
- C) Satisfy the **Writing Requirement** through completion of a minimum twenty (20) page paper on a subject related to conflict resolution. Certificate applicants should seek advanced approval of their writing project from the Director or Associate Director of the Kukin Program for Conflict Resolution to ensure that it meets the criteria for the Certificate.

Below is a list of courses that meet the five competencies, as well as the approved litigation courses that qualify for up to three (3) credits. Occasionally, courses not on this list (including study abroad courses) may be counted towards the certificate, but only with permission of the Director and Associate Director of the Kukin Program for Conflict Resolution.

***Students must always check the registration materials for each semester to confirm that a particular course is being offered.***
