Food Waste and Virtue Ethics: A Critical Analysis of Corporate Food Waste Jurisprudence (job talk paper, submitted for publication Aug. 2025)

This paper provides a comprehensive theoretical review of federal corporate food waste legislation, arguing that five decades of virtue-based regulation has failed because virtue ethics is fundamentally incompatible with profit-driven corporate entities. It proposes replacing voluntary compliance mechanisms with a consequentialist-based federal framework that would establish definitive corporate food waste donation metrics, challenging foundational assumptions about corporate virtue in environmental law.

From Seed to (RE)sale: How Cannabis Waste Policies Can Build a Circular Economy (work in progress)

This paper extends waste lifecycle analysis to cannabis, arguing that current state-by-state "Seed-to-Sale" tracking requirements exhibit "moral myopia" by mandating cannabis waste be rendered "unusable and unrecognizable," which prevents environmentally beneficial composting or recycling. It proposes a "Seed-to-(RE)sale" framework based on circular economy principles that would require production responsibility for the complete cannabis lifecycles, arguing that federal environmental standards for cannabis are constitutionally permissible under commerce power despite its Schedule I status.
