Online Course Archive

The New York Court of Appeals limits the number of credits that students who wish to be admitted to practice in NY can take via "distance education." Any Cardozo course that is offered in an all-remote format counts as a "distance education" course. **JD Students** can take no more than 15 credits in courses offered solely in a remote format. **LLM Students** may not count credits they have earned for online courses towards the NY bar requirements. Students are responsible for keeping track of how many such credits they earn and abiding by the 15-credit limitation if they wish to take the New York bar exam. Please note that other states' requirements may differ and students should make sure to abide by any limitations imposed by states in which they seek admission to practice.

Please note, this may not be an exhaustive list.

All credits taken in the Bioethics and Medical Humanities program (BIOE) count as distance education and are thus omitted from this list.
