## Application Procedure

Students who wish to study on exchange at HEAD must be nominated to do so by their home university. Upon nomination, students will be invited to complete an online application and to transmit required supporting documentation (CV, personal statement, ID or passport, university transcripts, and French language test results). Application dates are indicated to students in the email they will receive.

## Eligibility and requirements

Both Bachelors and Masters programs at HEAD welcome exchange students.

**\*Exchange students must have completed their semester (s) during their year in the partner university.**

**\*Bachelors: B2 Level of French is mandatory**

**\*Masters: B2 level of English is mandatory and B2 level of French is recommended.**

## Academic Program

- Exchange students may register for between **5 ECTS** credits (minimum) and **30 ECTS** credits (maximum) per semester. Students can attempt up to **60 ECTS** credits per academic year.

- Exchange Students can choose between law courses, humanities courses, management courses and professional courses to validate the number of ECTS required by the partner university
- Please note that more than 50% should be law courses.
- Masters student can have the opportunity to do an internship in a firm.
