

Paid Summer Public Service Internships and Funding Sources

It is possible to spend your summer doing public service work AND getting paid for it!

There are two ways to do this: (1) Find an actual paid internship in the government or nonprofit sector OR (2) Get an unpaid internship and find another source of funding.

(1) Finding a Paid Summer Public Service Internship

Although you shouldn't limit your search to paid public service internships (there just aren't that many), many of these opportunities do exist, especially if you are geographically flexible! See Section (3) below for a list of paid public service internship programs and other funding sources. Additional opportunities can be found on Symplicity, as well as on the following websites:

- <u>PSJD</u>: When using the PSJD Advanced Search for Job Postings, select "Internship (Summer)" under Job Schedule and "Stipend" and "Dependent on Experience" under Salary. This will return jobs with employers that offer paid internships.
- Government Honors & Internship Guide ("Arizona Handbooks"): This guide to federal, state, and local government internships allows you to look up internships by deadline for your class year and states whether a position is paid or unpaid. (Cardozo password: Cardozo123)
- <u>USAJobs.gov</u>: Look for "Pathways" summer internships, which are paid internships that also earn you time-in-grade for the Federal Government pay grades.

Once you have an offer, even if it's unpaid, ask the employer if any funding is available! Although some public service employers post their internships as "volunteer" opportunities, they may have limited funds available to pay you and/or at least provide a transportation subsidy. <u>Talk to OCS</u> about how best to have this conversation.

(2) Finding Funding for an Unpaid Summer Public Service Internship

If you get an unpaid internship, there are plenty of potential sources of funding, including but not limited to bar associations, foundations, and nonprofit organizations. And these are all in addition to <u>Cardozo's own funding sources</u>, including our Public Interest/Public Service Stipend and the Squadron Fellowships in Law, Media, and Society. When looking for other potential funding sources, think about:

- Your geographic location—in addition to NYC, consider where you are from and where you'll be
 working over the summer. There may be stipends available specifically for work in your home
 state or hometown.
- The **practice area** of your internship—there are many sources of practice area-specific funding, such as for work in consumer protection or immigrants' rights.
- Any affinity groups with which you identify—there are funding sources specifically intended for members of certain groups.

Treat applications for funding with the seriousness of a job application. Feel free to contact OCS for help.

(3) Sources of Paid Summer Public Service Internships & Other Funding Sources

Below are some sources of paid summer public service internships and other funding by practice area and their locations. Application deadlines may fall anytime during the academic year, so check their websites as early as possible and plan accordingly. **This is <u>not</u> an exhaustive list.** New opportunities constantly arise, and additional paid summer public service internships and funding sources can be found on Symplicity, PSJD, the Arizona Handbooks (password Cardozo123), USAJobs, and elsewhere.
